

Decree of the President of the Council of Ministers 22 March 2020 'Further provisions implementing the decree-law of 23 February 2020, n. 6 on urgent containment and management measures of the epidemiological emergency from COVID-19, applicable to the whole of the national territory'. (20A01807) (OJ N. 76 of 22-3-2020)

Art. 1

Urgent measures to contain the contagion on the whole national territory

- 1. In order to combat and contain the spread of the COVID-19 virus, the following measures are adopted on the whole national territory:
 - a) all industrial and commercial activities are suspended, with the exception of those listed in attachment 1 and except for what is provided for hereafter. Professional activities are not suspended and the provisions laid down in art. 1, par. 7, of the Prime Minister's Decree of 11 March 2020 remain effective. For the public administration, art. 87 of the Decree-Law n. 18 of 17 March 2020 remains effective. For commercial activities, the provisions laid down in the Prime Minister's Decree of 11 March 2020 and in the ordinance of the Minister of Health of 20 March 2020 remain effective. The list of codes referred to in attachment 1 may be amended by a decree of the Minister of Economic Development, after consultation with the Minister of Economy and Finance;
 - b) all natural persons are prohibited from moving with either public or private transportation to a different municipality from the one where they currently are, except for proven reasons of work, extreme urgency, or health; accordingly, in art. 1, par. 1, letter a) of the Prime Minister's Decree of 8 March 2020 the words "It is allowed to return to one's place of abode, dwelling, or residence" are deleted;
 - c) the productive activities which are suspended pursuant to letter a) may continue provided that they are carried out from home;
 - d) the activities necessary to guarantee the continuity of the supply chains of the activities referred to in attachment 1, as well as of the services of public utility and the essential services referred to in letter e) remain allowed, after notifying the Prefect of the Province where the productive activity is based, specifying the companies and the branches of the public administration receiving the goods and services of the allowed activities; the Prefect may suspend these activities if he considers that the conditions set forth in the previous sentence are not met. Until the adoption of the measures to suspend it, the activity is lawfully carried out on the basis of the submitted notification;
 - e) activities providing services of public utility and the essential services referred to in Law n. 146 of 12 June 1990 are allowed. Access to museums and other institutes and places of culture referred to in art. 101 of the Code of Cultural Heritage, as well as to education facilities, remains suspended, unless such services are provided from home to the extent permitted by law;
 - f) the activity of production, transport, sale, and delivery of medications, healthcare technology, and surgical-medical devices, as well as agricultural and food products, is always allowed. Any other activity necessary to tackle the emergency also remains allowed;
 - g) the activities of continuous production plants, whose closure would result in serious damage to the plant or risk of accidents, are allowed, after notifying the Prefect of the Province where the productive activity is based. The Prefect may suspend these activities

if he considers that the conditions set forth in the previous sentence are not met. Until the adoption of the measures to suspend it, the activity is lawfully carried out on the basis of the submitted notification. However, the activity of the aforementioned plants aimed at guaranteeing the provision of an essential public service is not subject to notification;

- h) the activities of the aerospace and defence industry, as well as all other strategic activities for the national economy, are allowed, with prior authorisation of the Prefect of the Province where the productive activities are based.
- 2. The Prefect shall inform the President of the Region or the President of the Autonomous Province, the Minister of the Interior, the Minister of Economic Development, the Minister of Labour and Welfare, and law enforcement about the received notifications and the adopted measures.
- 3. The companies whose activities are not suspended shall comply with the provisions set forth by the protocol on the measures to combat and contain the spread of the COVID-19 virus at the workplace signed by the Government, business associations, and trade unions on 14 March 2020.
- 4. The companies whose activities are suspended in compliance with the present decree shall complete the tasks necessary for the suspension by 25 March 2020, including the shipment of goods in stock.

Art. 2

Final provisions

- 1. The provisions of the present Decree shall enter into force from 23 March 2020 and shall remain effective until 3 April 2020. These provisions shall apply together with the provisions laid down in the Prime Minister's Decree of 11 March 2020 and in the ordinance of the Minister of Health of 20 March 2020, whose duration is extended from 25 March 2020 to 3 April 2020.
- 2. The provisions of the present Decree shall apply to the Regions with a special status and to the Autonomous Provinces of Trento and Bolzano, with due regard to their respective statutes and implementing rules.
